Terms and Conditions

1. This **“Menang Kaw Kaw”** Promotion (**“Promotion”**) is organised by U Mobile Sdn Bhd (Registration No: 199101013657 (223969-U)) (**“U Mobile”**) which commences at 00:00 a.m on 28th October 2024 and ends at 11:59 p.m on 28th February 2024 (**“Promotion Period”**).

2. By participating in this Promotion, you agree to be bound by all the terms and conditions below (**“Terms and Conditions”**).

3. **Promotion Eligibility**

a. This Promotion is open to Malaysian citizens who are above the age of 12 years old (collectively, **“Eligible Participants”**);

b. This Promotion is available at all 99 Speed Mart’s outlets in Peninsular Malaysia.

c. Any consents, indemnities, agreement, undertakings, representations and warranties given under these Terms and Conditions by Eligible Participants who are below the age of 18 years old are deemed to have been given by their parents or guardians.

d. U Mobile reserves the right to reject any application by any participants without assigning any reason.

ii. Subscribe to any of U Mobile 5G Prepaid monthly plans (U25, U35, U40 & U50) within 1 day from the date of activation of the Prepaid Starter pack (purchased under paragraph 4(a)(ii) above (**“Active with Plan”**); and

iii. Participants must purchase a data plan (5G Prepaid monthly plan i.e U25, U35, U40 and U50) for 3 consecutive months during the Promotion Period.
